Data Submission Deadlines

Reminder! The **submission deadline** for **Quarter 1 2023** reporting period (January 1—March 31, 2023) clinical data [including **OP-2**: Fibrinolytic Therapy Received Within 30 Minutes of ED Arrival; **OP-3**: Median Time to Transfer to Another Facility for Acute Coronary Intervention; **OP-18**: Median Time from ED Arrival to ED Departure for Discharged ED Patients; and **OP-23**: Head CT or MRI Scan Results for Acute Ischemic Stroke or Hemorrhagic Stroke Patients who Received Head CT or MRI Scan Interpretation Within 45 Minutes of ED Arrival] into the **Hospital Quality Reporting (HQR) system** is **August 1, 2023, 11:59 p.m. Pacific Time (PT)**. Submission of Hospital OQR Program Population and Sampling data is voluntary.

The **submission deadline** for **Quarter 1 2023** reporting period (January 1—March 31, 2023) **OP-38**: COVID-19 Vaccination Coverage Among Healthcare Personnel (HCP) measure data into the **National Healthcare Safety Network (NHSN) system** is **August 15, 2023, 11:59 p.m. PT**. Abstraction Guidance Spotlight: Changes to the Sex Data Element

The data element, **Sex**, has been updated to capture additional information to help evaluate health equity. This update is effective **beginning with July 1, 2023, encounters**. *The Description of Changes* are as follows:

- **Definition:** The patient's documented sexual orientation and/or gender identity.
- **Suggested Data Collection Question:** What is the patient's sexual orientation and/or gender identity?
- **Format:** *Change Type To:* Alphanumeric, *Change Occurs To:* 1 – 5.
- **Allowable Values:** Select all that apply: 1. Male, 2. Assigned/Designated Male at Birth, 3. Female, 4. Assigned/Designated Female at Birth, 5. LGBTQ, 6. Unknown.

Coming Soon: CY 2024 Proposed Rule

The Calendar Year (CY) 2024 Outpatient Prospective Payment System (OPPS)/Ambulatory Surgical Center (ASC) Proposed Rule is scheduled to be published in the *Federal Register* in July. An email notification will be released when the proposed rule is available. The Centers for Medicare & Medicaid Services (CMS) urges the Hospital OQR community to participate in the Proposed Rule comment process, as public comments are vital. The **60-day comment period** will open once the proposed rule is published. Comments can be submitted at [www.regulations.gov](#), or through mail if postmarked by the last day of the comment period.
