**Subject:** FY 2024 Hospital VBP Program Percentage Payment Summary Reports  
Now Available for Review

Hospitals can now access the Centers for Medicare & Medicaid Services (CMS) Percentage Payment Summary Reports (PPSRs) for the fiscal year (FY) 2024 Hospital Value-Based Purchasing (VBP) Program. Participating hospitals can immediately access their FY 2024 Hospital VBP Program PPSR through the *Hospital Quality Reporting Secure Portal*. These FY 2024 reports include hospitals' Total Performance Score (TPS) and value-based incentive payment adjustments.

### **Review and Corrections and Appeals**

Hospitals may review and request recalculation of the performance scores on each condition, domain, and TPS **within 30 calendar days** of the posting date of the PPSR List Serve Announcement on QualityNet. The review and corrections period begins August 11, 2023, and ends at 11:59 p.m. Pacific Time (PT) on September 11, 2023. Neither the review and corrections process nor the appeal process allows hospitals to submit corrections related to the underlying data or claims, or add new data or claims, to the data extracted to calculate the rates.

**Note:** Hospitals can only request an appeal after requesting a review and correction of their performance scores and receiving a decision from CMS that denies their review and corrections recalculation request. Hospitals that do not submit a review and correction request within 30 calendar days of the release of the FY 2024 PPSRs List Serve Announcement on QualityNet will waive eligibility to submit a Hospital VBP Program appeals request for the applicable program year.
